ISWP Integration Subcommittee Wednesday, July 14, 2021 Meeting Minutes

The ISWP Integration Subcommittee met by conference call on Wednesday, July 14, 2021 from 7:00 a.m. to 8:00 a.m. U. S. Eastern Daylight Saving Time/11:00 a.m. to 12:00 p.m. GMT. This provides the meeting minutes.

Discussion:

- Approval of Previous Meeting Minutes: There were no changes to the June 9, 2021 meeting minutes.
- WHO Basic Manual Review: Amira Tawashy reviewed progress on the manual review and summarized changes to be made, which include revisions to core content and drawings and inclusion of peer-reviewed literature.

Amira presented proposed tasks (see below) and requested Subcommittee members' assistance to help lead the completion with the support of Subject Matter Experts (SMEs). The Subcommittee member would lead a meeting, if the subject matter expert requests, to review the requested input and make modifications. Other Subcommittee members are invited to attend as they would like. Amira has some key questions which can be used as thought starters during the conversations.

Paula Rushton suggested inviting subject matter experts who are working on the WFOT position paper on wheelchair service provision, which Hassan Sarsak is leading.

- 3. **Wheelchair Educators' Package**: The Steering Committee continues to collaborate with the website developer to create the site. The project is on track to have the website ready on August 8. Upcoming milestones:
 - August 9-20: Internal review. About half of development team is participating.
 - August 23-Sept. 17: External review.

Two Working Groups are active: The Participatory Action Research (PAR) Working Group is developing processes and forms for internal/external reviews and planning for the data analysis. The Scoping Review Working Group is preparing a results paper; goal is to submit by August 27.

Other Working Groups are on pause during summer (Advocacy, Planning/Course Development and Implementation/Improvement) since content they developed is being added to site. The Pilot Sites Working Group is on pause until October, when the internal and external reviews are complete. Pilots are scheduled to take place January-June 2022.

A presentation on the Wheelchair Educators' Package will be made at the International Seating Symposium (ISS) in October.

Regarding publications, one scoping review paper has been published, and one is in development. Other publications planned: PAR methods and results and WEP development.

- Academic Training Partners: The 26th meeting of the training partners was on Monday, July 19, 9:00 a.m. U.S. Eastern Daylight Saving Time/1:00 p.m. GMT. Sandra VEelasco Universidad Rosario, Colombia presented. Sara Munera Orozco did a live translation from Spanish to English. Link to the recording.
- ISWP Central Update: ISWP submitted a work plan to UNOPS for continued support for ISWP beginning October 1 and submitted a revised plan based on UNOPS' and USAID's feedback. The Bylaws Subcommittee, comprised of 6 Founding Board members, is reviewing a draft Policies and Procedures Manual. The Founding Board will meet on August 9.

Publications:

- a. The French-Canadian translation paper was not accepted. Co-authors will consider submitting to Disability and Rehab AT. Paula has published other translation papers there. The University of Montreal summer intern will help to reformat for submission.
- b. Work continues on the joint position paper. The team received feedback on including more information on recent initiatives, with social media being a way to source the content. Goal is to finalize a draft this summer.
- c. Lee Kirby reported that a paper based on the wheelchair skills training global survey was submitted for publication last week. The paper covered 309 responses from 35 countries in all 6 regions of world.
